The Energy Utility Corporation Limited (EUCL) hereby invites sealed bids from eligible bidders for submitting their best offers for **SUPPLY OF CHEMICALS TO USE IN MAINTENANCE OF EUCL POWER PLANTS UNDER FRAMEWORK CONTRACT FOR THE ENERGY UTILITY CORPORATION LIMITED (EUCL)** as indicated in detail in the statement of Requirements. The tender is comprised of two (2) lots:

LOT 1: CHEMICALS AT THE PEAT POWER PLANT
LOT 2: CHEMICALS USED AT THERMAL POWER PLANT

Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the Procurement User Manual of REG. Please note that the two lots mentioned above will be independent of each other hence a potential bidder can bid for both lots but will only be awarded only one lot of the two.
