#### 1. Objective of the Services

The objective of the assignment is to recruit a competent firm to undertake training of EDCL project managers and other staff in the sphere of project management in certified Project management Professionals (PMP). The consultant firm will be required to undertake the following overall objectives:

- To provide certificates to project managers that will aid the transition to professional project management, reducing project time and cost overruns by focusing on below subjects

- Recognize the components of a project charter and how to be appropriately scale them based on the size of a project.
- d. Understand the role of the "triple constraint" in project management and apply it in determining project scope.
- e. Keep projects on track by managing project risks and effectively using a communication plan.
- f. Capture valuable project lessons and use them to define and improve project management practices within your organization.
- g. Develop an action plan for continuing to expand your project management knowledge.
- h. To practically acclimatize EDCL project management team with the subject of project management across the standard project cycle from initiation all through project closure.
- i. To gain comprehensive understanding of project management knowledge, with experience and skills to bring projects to successful completion in EDCL

### Duration of the assignment

It is expected that the work will require a total period of one year.

The consultant firm will be selected in accordance with the Law N°62/2018 of 25/08/2018 governing public procurement in Rwanda and through the Quality and Cost Based Selection.

# TERMS OF REFERENCE FOR THE RECRUITMENT OF A FIRM TO TRAIN EDCL PROJECT MANAGEMENT STAFF IN PROJECT MANAGEMENT PROFESSIONAL (PMP)

### 1. Background

Energy Development Corporation Ltd (EDCL) is a subsidiary arm of Rwanda Energy Group that oversees the development and implementation of power generation, transmission and distribution projects. EDCL is thus a project-based company. Further, being a growing company, management pursues a deliberate policy to ensure institutional and human capacity development across the business value-chain, from project and contract management, procurement, finance and accounting specialities. EDCL with support from ENABEL has secured funding to enhance staff capabilities in project management.

## 2. Rationale for the Assignment

The rationale for this task is to secure a competent firm to undertake training of EDCL project managers and other staff in the sphere of project management in certified Project management Professionals (PMP). #### 11. Consultant Selection Criteria

The selection process will be undertaken through the Rwandan Public Procurement regulations, under an article 35 regarding the selection pf consultants by quality-cost based selection method, with additionally consideration of Firm Experiences and Qualifications of key staff and Team members.

The consultant firm shall indicate in its proposal a detailed man-months for proper execution of the training. Considering the technical and financial evaluation, contract shall be awarded to a consultant firm whose combined technical and financial result meets evaluation criteria.

The consultant firm must propose and provide a schedule with breakdown for the various activities called for in the TORs, including the face to face and online sessions or masterclasses.

## 12. Implementation Modalities

The course will be implemented through face-to-face training whilst observing COVID-19 social distancing guidelines. Details of the course implementation arrangements will be completed upon receipt of the proposals from preferred bidders as part of the inception phase. The final methodology shall be agreed upon between EDCL and the trainer during the inception phase of this exercise.

### 13. Reporting Requirements

The Consultant will report to the Managing Director of EDCL or other representative, Consultant will produce the following reports:

- Monthly Progress report including the execution of work plan
- Quarterly Progress, when applicable
- Invoices for each Deliverable which submitted

### 14. Training Fees

The consultant firm should submit their financial proposal, and breakdown of the following different fees:

- 1. Registration fees
- 2. Tuition fees
- 3. Exam Preparation fees
- 4. PMP exam fees
- 5. And any other related fees to be considered.
