The Government of Rwanda has received financing from OPEC Fund (the Fund) and the SFD toward the cost of the Rwanda Universal Energy Access Project and intends to apply part of the proceeds toward payments under the Contract for Design, Supply, and Installation of low voltage and medium voltage lines and service connections in Gakenke District.

For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the OPEC Fund's and SFD's Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.

The Energy Development Corporation Limited (EDCL) now invites sealed Bids from eligible Bidders for Design, Supply, and Installation of low voltage and medium voltage lines and service connections in Busengo, Coko, Cyabingo, Gakenke, Gashenyi, Janja, Kamubuga, Karambo, Kivuruga, Mataba, Minazi, Mugunga, Muhondo. Muyongwe, Muzo, Nemba, Ruli, Rusasa, Rushashi in Gakenke District.

3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the OPEC Fund's and SFD's "Procurement Regulations and is open to all eligible Bidders as defined in the Procurement Regulations.

6. Bids must be delivered to the address below on or before **21/09/2021 at 10:00am (local time)**. Electronic bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below **on 21/09/2021 at 10:30am (local time)**
7. All Bids must be accompanied by a Bid Security of US\$ 18,000.
8. A non-compulsory site visit is scheduled on **18/08/2021** and the meeting point is Gakenke District Office at **10:00pm**.
9. A pre-bid meeting shall take place online on **24/08/2021** from **10:00am (local time)**.
