1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Development Business, issue of **7th July 2009**.
2. The **Government of Rwanda** received a loan from the BADEA FUND FOR DEVELOPMENT (SFD) towards the cost of Increasing Access to Electricity to some areas in Rwanda Project, and it intends to apply part of the proceeds of this loan to payments under the Contract for **Supply of Cables, Conductors and Accessories** as follows:
Lot 1: LV Cables and LV line accessories and **Lot 2: Conductors and joint accessories**
3. **EDCL** now invites sealed bids from eligible and qualified bidders for the tender to **Supply of Cables, Conductors and Accessories**.
4. Bidding will be conducted through the **International Competitive Bidding (ICB)** procedures specified in the **BADEA FUND FOR DEVELOPMENT's Guidelines: Procurement of Goods and Contracting for Execution of Works**, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.

6. Qualification requirement include:

The Bidder shall furnish average annual revenue for the two years prior to bid submission must be at least twice the bid price.

The Bidder shall furnish and include in its bid documentary evidence to demonstrate that it meets the following experience requirement(s):

- i. Proof that goods offered shall be from Manufacturers that have at least three years of experience in manufacturing the required equipment.
 - ii. Type test reports certified by an internationally recognized testing facility acceptable to the Employer.
 - iii. A minimum of three (3) contracts of similar scope and value to the offered goods executed in the last ten (10) years supported by copies of delivery notes and Certificates of Good performance.
