The Government of Rwanda has received a financing from the International Development Association (IDA) towards the cost of Rwanda Electricity Sector Strengthening Project (RESSP), and it intends to apply part of the proceeds of this loan to payments under the Contract for PLANT DESIGN, SUPPLY, AND INSTALLATION OF LOW VOLTAGE AND MEDIUM VOLTAGE LINES AND SERVICE CONNECTIONS IN THE KARONGI AND RUTSIRO DISTRICTS, WESTERN PROVINCE OF RWANDA.
- 3. ENERGY DEVELOPMENTCORPORATION LIMITED (EDCL) now invites sealed bids from eligible and qualified bidders for the tender for PLANT DESIGN, SUPPLY, AND INSTALLATION OF LOW VOLTAGE AND MEDIUM VOLTAGE LINES AND SERVICE CONNECTIONS IN THE KARONGI AND RUTSIRO DISTRICTS AND WESTERN PROVINCE OF RWANDA.

IDA Credits, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.

- 5. Interested eligible bidders may obtain further information **ELECTRICITY ACCESS ROLL OUT PROGRAM (EARP)** and inspect the bidding documents at the address given below from **08 00 to 17 00 hours local time.**
- 6. A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of **Fifty US Dollars (USD 50)** or an equivalent amount in a freely convertible currency deposited to the account called **RECO/EARP N° 1230070** opened at **BNR (National Bank of Rwanda).**
- 7. Bids must be delivered to the address below <u>at or before 10 00 hours local time</u> on day 15/11/2018. Electronic bidding <u>will not</u> be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at <u>10</u>: 30 hours, local time on the same day 15/11/2018.
- 8. All bids must be accompanied by a **Bid Security of US\$ 40,000** or an equivalent amount in a freely convertible currency.
