The **Government of Rwanda** has received a financing from the International Development Association (IDA) towards the cost of **Rwanda Electricity Sector Strengthening Project (RESSP)**, and it intends to apply part of the proceeds of this loan to payments under the Contract for **Plant Design, Supply, and Installation of Low Voltage and Medium Voltage Lines for Productive Users in Rwanda.**
3. **Energy Development Corporation Limited (EDCL)** now invites sealed bids from eligible and qualified bidders for the tender for **Plant Design, Supply, and Installation of Low Voltage and Medium Voltage Lines for Productive Users in Rwanda.**
4. Bidding will be conducted through the **International Competitive Bidding (ICB)** procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.

A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of **Fifty US Dollars (USD 50)** or an equivalent amount in a freely convertible currency deposited to the account called **RECO/EARP N° 1230070** opened at **BNR (National Bank of Rwanda)**.
 7. Bids must be delivered to the address below at or before 10 00 hours local time on day **15/11/2018**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at 10: 30 hours, local time on the same day **15/11/2018**.
 8. All bids must be accompanied by a **Bid Security of US\$ 40,000** or an equivalent amount in a freely convertible currency.
