The Government of Rwanda has received a grant from the Belgian Kingdom within the framework of “Improving Access to Reliable On-grid Electricity Service for Households and Public Priority Institutions –Belgian contribution to EARP; intends to apply a portion of the funds to eligible payments under the contract Supply of protective and safety equipment; Ref No: 001/G/2018/ICB/BEEARP
2. EDCL/BEEARP project invites eligible bidders to submit bids for the Supply of protective equipment, as indicated in detail in the statement of Requirements.

7. All bids must be accompanied by a *Bid Security* issued by a bank. of :

Lot II: 600 Euros or 600,000Frw

Lot III: 8000 Euros or 8,000,000 Frw

The bid security shall be valid for a minimum of 30 days beyond the deadline of the extended validity period of the bid


