The Government of Rwanda has received financing from OPEC Fund (the Fund) and the SFD toward the cost of the Rwanda Universal Energy Access Project and intends to apply part of the proceeds toward payments under the Contract for Design, Supply, and Installation of low voltage and medium voltage lines and service connections in Muhanga District.

For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the OPEC Fund's and SFD's Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.

The Energy Development Corporation Limited (EDCL) now invites sealed Bids from eligible Bidders for Design, Supply, and Installation of low voltage and medium voltage lines and service connections in Cyeza, Kabacuzi, Kiyumba, Nyabinoni, Nyamabuye, Nyarusange, Rongi, Rugendabari, Shyogwe in Muhanga District.

3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the OPEC Fund's and SFD's "Procurement Regulations and is open to all eligible Bidders as defined in the Procurement Regulations.
