The Energy Development Corporation Limited (EDCL) now invites sealed Bids from eligible Bidders for Design, Supply, and Installation of low voltage and medium voltage lines and service connections in Cyeza, Kabacuzi, Kiyumba, Nyabinoni, Nyamabuye, Nyarusange, Rongi, Rugendabari, Shyogwe in Muhanga District.
 - 3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the OPEC Fund's and SFD's "Procurement Regulations and is open to all eligible Bidders as defined in the Procurement Regulations.
