Twiseguye ku bafatabuguzi bacu kubera ibura ry'umuriro rizaba mu gihe iyo mirimo izaba ikorwa.

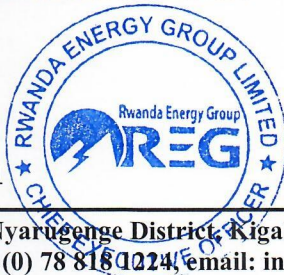
