1. Background

To this end, EUCL intends to engage the services of an individual consultant to be responsible for coordinating and streamlining procurement operations of the institution and skills transfer through capacity building in respect of the Country Procurement System, Company procurement Manuals as well as various Donors' Procurement Policies and guidelines.

In addition, the consultant will provide assurance to the MD that all EUCL procurements necessary for company's efficiency and effectiveness; are being conducted with strict adherence to procurement policy, procedures, legal and good governance standards; are completed without avoidable time delays; and once awarded, contracts are managed in a manner that maximizes value to the organization.

Expert Profile

Education: A Master's Degree in procurement or supply chain management or engineering or administration or law or any other relevant field with an experience of at least Five (5) years. A first degree in the above with an experience of at least Seven (7) years will also be acceptable. A demonstration of having held managerial positions in the consultant's work experience will be an added advantage.

Experience:

- Good knowledge of standard procurement methods and procedures for Rwanda and Donor Agencies, knowledge of UNCITRAL model law will be a distinct advantage;
- Experience in training, capacity building and setting up procurement systems in a new organisation will be a distinct advantage;

- Proven ability to work and interact with people from diverse, professional, social and cultural backgrounds;
- Fluency in written and spoken English and Kinyarwanda. Knowledge of French would be an added advantage;
