2. The tender is composed of one (1) lot and participation is open on equal conditions to all companies specialized in the field. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the Procurement User Manual of REG as updated to date.

4. A **Site visit is not compulsory to all interested bidders**, however in case any company want to do so, they must express the visit request before going to the site

Well printed bids, properly bound and presented in two copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned above not later **than 11/05/2022 at 10:00 am**. Late bids will be rejected and returned unopened. The bids should be well sealed and addressed to the following address:
