## Specific Procurement Notice

The Government of Rwanda *has received* financing from the World Bank toward the cost of the ***Energy Access and Quality Improvement Project***, and intends to apply part of the proceeds toward payments under the contract for ***Design, Supply, and Installation of Clean Institutional Cooking systems at Nine Public Schools in Rwanda***. “For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank’s Disbursement Guidelines for Investment Project Financing.”
2. The *Energy Development Corporation Limited (EDCL)* now invites sealed Proposals from the interested eligible Applicants for ***Design, Supply, and Installation of Clean Institutional Cooking systems at Nine Public Schools in Rwanda, located in Southern Province of Rwanda*** :  
**Lot 1: Electric Cooking System**  
**Lot 2: LPG Cooking System**
3. The procurement will be conducted through national competitive procurement using Request for Proposals (RFP) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers” September 2023 (“Procurement Regulations”) and is open to all eligible Proposers as defined in the Procurement Regulations.
4. Interested eligible Proposers may obtain further information from Energy Development Corporation Limited (EDCL); [procurement@edcl.reg.rw](mailto:procurement@edcl.reg.rw) with a copy to [jdruheranziza@edcl.reg.rw](mailto:jdruheranziza@edcl.reg.rw) inspect the RFP document during office hours (09:00 AM to 5:00 PM) at the address given below.

The RFP Document in *English* may be purchased by initially selected eligible Proposers upon the submission of a written application to the address below and upon payment of a nonrefundable fee of 50 USD or in a convertible currency. The method of payment will be deposit on the Bank Account N° 1000057734 in USD opened at National Bank of Rwanda in the name of EDCL EAQIP IDA Designated Account, Swift Code: BNRWRRW. The document will be sent by e-mail.
6. A single-stage, where two envelope RFP process will be used, and the Proposal will consist of (i) the Technical Part, without any reference to prices; and (ii) the Financial Part, as detailed in the RFP Document. The Technical and Financial Parts of the Proposals shall be submitted simultaneously in two separate sealed envelopes.
7. The Proposal, both the Technical Part and the Financial Part, must be delivered to the address below on 19/04/2024 at 10:30am (local time).. Electronic Procurement will not be permitted. Late Proposals will be rejected. The Technical Part of the Proposals will be publicly opened in the presence of the Proposers’ designated representatives and anyone who chooses to attend at the address below on 19/04/2024 at 11:00am (local time). The Financial Part shall remain unopened and will be held in safe custody of the Employer until the second public opening of the Financial Part, following the evaluation of the Technical Part of the Proposals.

8. All Proposals must be accompanied by a “*Proposal Security*” of 3,300USD for lot 1 and 11,600USD for lot 2 or in convertible currency.
  9. The non-compulsory site visit is scheduled on 03/04/2024 and the meeting point is Lycée Notre Dame de Citeaux Kigali at 11:00am.
  10. The pre-bid meeting shall take place on the site at the end of site visit on the same day.
  11. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful Proposer’s beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the RFP document.
