For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.

The **Energy Development Corporation Limited (EDCL)** now invites sealed Bids from eligible Bidders for **DESIGN, SUPPLY, AND INSTALLATION OF LOW VOLTAGE AND MEDIUM VOLTAGE LINES AND SERVICE CONNECTIONS IN BUKURE, BWISIGE, BYUMBA, CYUMBA, GITI, KAGEYO, MANYAGIRO, MIYOVE, MUKARANGE, MUKO, MUTETE, NYAMIYAGA, NYANKENKE, RUBAYA,**

6. Bids must be delivered to the address below on or before **04/03/2021 at 10:00am (local time)**. Electronic bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **04/03/2021 at 10:30am (local time)**.
7. All Bids must be accompanied by a **Bid Security of US\$ 240,000**.
