The Government of Rwanda *has received* financing from the World Bank toward the cost of the Rwanda Energy Access and Quality Improvement Project (EAQIP) and intends to apply part of the proceeds toward payments under the contract for Renovation of the fence and levelling works of Kalisimbi regional store.: "For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing,"
- 2. The **Energy Development Corporation Limited** (EDCL) now invites sealed Bids from eligible National Bidders for Renovation of the fence and levelling works of Kalisimbi regional store *which will be constructed within 3 months, in Nyabihu District, Western Province of Rwanda,*
- 3. Bidding will be conducted through national competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers *Fifth Edition, September 2023* ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
- 4. Interested eligible Bidders may obtain further information from EDCL, procurement@edcl.reg.rw copy to cuwajeneza@edcl.reg.rw and jdruberanziza@edcl.reg.rw and inspect the bidding document during office hours *from 09:00 AM to 17:00 PM* at the address given below.
- 5. The bidding document in English may be purchased by interested eligible Bidders upon payment of a nonrefundable fee of 50 USD (**receipt to be sent by email**). The method of payment will be deposit on the Bank Account N° 1000057734 in USD opened at National Bank of Rwanda in the name of EDCL EAQIP IDA Designated Account, Swift Code: BNRWRWRW. The document will be sent by e-mail.
- 6. Bids must be delivered to the address below on or before 5/02/2024 at 10:30am (local time). Electronic bidding will not be permitted. Late Bids will be rejected. The outer Bid envelopes marked "ORIGINAL BID", and the inner envelopes marked "TECHNICAL PART" will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend, at the address below on: 05/02/2024 at 11:10 am (local time). All envelopes marked "FINANCIAL PART" shall remain unopened and will be held in safe custody of the Employer until the second public Bid opening.
- 7. All Bids must be accompanied by a Bid Security of 3,200USD or equivalent in FRW, issued directly by a bank or a local insurance company. Swift transaction guarantees are not acceptable.
- 8. Site visit is scheduled, and the meeting point is at Nyabihu District Headquarter on 12/01/2024, 10:00am (Local time).
- 9. The physical pre-bid meeting shall take place on 12/01/2024 from 11:00am (local time) at the site.
