The Government of Rwanda has received financing from World Bank (WB) and Agence Française de Développement (AFD) toward the cost of the Energy Access and Quality Improvement Project, and intends to apply part of the proceeds toward payments under the Contract for Design, supply and Installation and commissioning of -40/+20 MVAR static VAR Compensator (SVC) for 220kV SHANGO & RWABUSORO substations.

For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.

- 2. The Energy Development Corporation Limited (EDCL) now invites sealed Bids from eligible Bidders for Design, supply and Installation and commissioning of -40/+20 MVAR static VAR Compensator (SVC) for 220kV SHANGO & RWABUSORO substations.
- 3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" December 2019 ("Procurement Regulations") and is open to all eligible Bidders as defined in the Procurement Regulations.

The bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of 50 USD. The method of payment will be deposit on the Bank Account N° 1000023217 opened at National Bank of Rwanda in the name of RECO/EARP COUNTER PARTS FUNDS (RWF) Swift Code: BNRWRWRW. The document will be sent by e-mail.
- 6. Bids must be delivered to the address below on or before 02/03/2021 at 10:00am (local time). Electronic bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on 02/03/2021 at 10:30am (local time).
- 7. All Bids must be accompanied by a Bid Security of **US\$ 170,000**.
