Prior registration through purchase of the Bidding Document is required for submitting clarification questions on the Bidding Document and receiving automatic notice of answers and of addenda to the Bidding Document.

A mandatory site visits to the various substations, shall be conducted by the Employer and will take place from 28<sup>th</sup> August 2019 to 3<sup>rd</sup> September 2019. A pre-bid meeting will take place on the first day of the site visit i.e. 28<sup>th</sup> August 2019 at 7:00am at EUCL Headquarter, before set off. Bidders or their designated representative are strongly encouraged to attend the pre-bid meeting and site visit.

Bids must be delivered to the address below <u>before or not later than 10:30am local time</u> on 18<sup>th</sup> September 2019. Electronic bidding <u>will not</u> be permitted. Late bids will be rejected and returned unopened.



Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at 11:00 am local time on the same day.

Well printed bids, properly bound and presented in **two copies** (**one original and one copy**) must be accompanied by a bid guarantee issued by a reputable bank and worth Three Million Rwandan Francs (3,000,000 Frw) in a sealed envelope. The bids will remain valid for **120 days** starting from the deadline of bids submission. The Outer envelope (containing the bid and bid guarantee) should clearly indicate the tender title and number.
