The **Government of Rwanda** has received a loan from the **International Development Association (IDA)** towards the cost of **Rwanda Electricity Sector Strengthening Project (RESSP)**, and it intends to apply part of the proceeds of this loan to payments under the Contract for the **Supply of 19,204 Single and 1,011 Three Phase Prepayment Meters for Fill in Connections**.
3. **The Energy Development Corporation (EDCL) Limited** now invites sealed bids from eligible and qualified bidders for the tender to **Supply of Single and Three Phase Prepayment Meters**.
4. Bidding will be conducted through the **International Competitive Bidding (ICB)** procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits*, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.

A complete set of bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of **Fifty Thousand (50,000) Rwandan Francs** or an equivalent amount in a freely convertible currency deposited to the account called **EARP Account Number: 1000023217/FRW** opened at **BNR (National Bank of Rwanda)**.

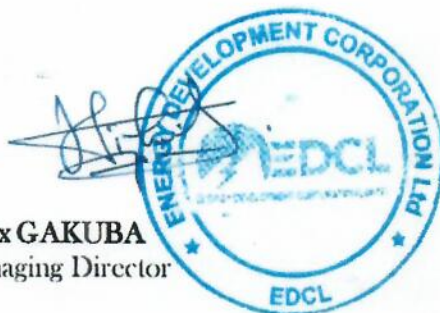
