The tender comprises of Eight (8) Lots mentioned below and the participation to the competition is open on equal conditions to all companies specialized in the field, the bidder is allowed to bid for all the lots but he will not be awarded more than two lots. The said lots are as follows;

LOT 1: CABLES & CONDUCTORS (Alu, ACSR & Steel) and ACCESSORIES.

LOT 2: LV & MV UNDEGROUND CABLES (Copper) and ACCESSORIES

LOT 3: INSULATORS AND LINE HADWARE

LOT 4: PROTECTION & ISOLATION

LOT 5: TRANSFORMERS

LOT6: TRANSFORMER OIL, SILICA GEL AND OTHERS LOT 7: TOOLS AND OTHER CONSUMABLE HARDWARE

LOT 8: OFC and SCADA Materials

Bidding will be conducted through the International Competitive Bidding (ICB) in accordance with the Procurement Procedures Manual of REG/EUCL as modified to date. Bids must be delivered at the address below at or before 10h00 local time on the **31**st/**05**/**2018**. Electronic bidding will not be permitted. Late bids will be rejected.

Bids will be opened in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices in a public session at 10h30 local time on the same day 31st/05/2018.



Bids well typed, appropriately bound and presented in four copies (one original and three copies) must be accompanied by a bid guarantee of Five Million Rwandan Francs (**5,000,000 Rwf**) or Five Thousand Eight Hundred and Fifteen US Dollars (USD **5,815**) issued by a recognized Financial Institutions agreed by National Bank of Rwanda **for each lot**, must reach the Secretariat to the Procurement Unit at EUCL Head Office, KN 2 ST 3, Nyarugenge District, P.O. Box 5634 Kigali City – Rwanda, Room G114 on or before the date and time mentioned above. The Outer envelope should clearly indicate the tender number and title.

The bids will remain valid for 120 days starting from the deadline of bids submission.
