1. Energy Utility Corporation Limited (EUCL) now invites sealed bids from eligible bidders for the TENDER FOR SUPPLY OF AUTO-RECLOSERS, UPS, BATTERIES AND OTHER ACCESSORIES FOR MAINTENANCE OF THE EXISTING AUTO-RECLOSERS UNDER FRAMEWORK CONTRACT. The tender is comprised of the Two (2) Lots:

Lot I: SUPPLY OF UPS, ARDUINO NANO V3, BATTERIES 12, 12AH, GSM SIM 800L AND LV TRANSFORMER 1000VA, 220/110VAC

Lot II: SUPPLY OF AUTORECLOSER WITH CONTROL UNIT AND UNIVERSAL RECLOSER TESTING KIT

2. Bidding will be conducted through National Competitive Bidding (NCB) in accordance with the Procurement Procedures Manual of REG/EUCL.

This payment shall be made to Account N° 25044962001/RWF opened at I & M Bank. Bids must be delivered to the address below **before or not later than 10:00am local time** on 09./04./2025. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.

All bids shall be accompanied by a bid security of Four Million Fifty Thousand Rwandan francs (Frw 4,050,000) for Lot I and One Million Five Hundred Thousand Rwandan Francs (Frw 1,500,000) for Lot II issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids
5. Bids will be opened in a public session in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day.**
6. Well printed bids, properly bound and presented in four copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned below not later than 09./04./2025 at 10:00 am. Late bids will be rejected and returned unopened.


