This payment shall be made to Account 25044962001/RWF opened at I & M Bank, Rwanda.
4. Bids must be delivered to the address below **before or not later than 10:00am local time** on/12/2021. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.
5. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day**.
6. Well printed bids, properly bound and presented in four copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned below not later than/12/2021 at **10:00 am**. Late bids will be rejected and returned unopened.

9. Site visit is scheduled from 13th up to 16th December 2021 in different EUCL's substations, only transport cost will be covered by EUCL. Departure time is 10h:00' AM at REG-EUCL Headquarters.
