4. It is important to note that the principles of procurement i.e. value for money, fairness, transparency and efficiency, will also be considered paramount in guiding the award process of this tender.
5. Bidding will be conducted through **International Competitive Bidding (ICB)** in accordance with the Procurement Procedures Manual of REG/EUCL.

8. Bids will be opened in a public session and in the presence of the bidders’ representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30” AM local time on the same day**.

Well printed bids, properly bound and presented in **four copies one of which is the original** must be accompanied by a bid guarantee of **Five Million Rwandan francs (Frw 5,000,000) for lot one (1)** or Five Thousand Five Hundred US Dollars (USD **5,500**) and **Three Million Rwandan Francs (Frw 3,000,000) for lot Two (2)** or Three Thousand Five Hundred US Dollars (USD **3,500**) issued by a reputable bank or other financial institutions. **Bidders must submit the bid securities with a validity period of 150 days from the date of issue by the bank or other financial institutions** and bids will remain valid for **150 days** starting from the deadline of bids submission. The Outer envelope (containing the bid and bid guarantee) should clearly indicate the tender title, Tender reference number and Lot number.
