This payment shall be made to Account 25044962001/RWF opened at I & M Bank, Rwanda.
4. Bids must be delivered to the address below **before or not later than 10:00am local time on 20/12/2021**. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.
5. Bids will be opened in a public session and in the presence of the bidders' representatives who ~~choose to attend in person in the conference room at EUCL Headquarter Offices at~~ **10:30 am local time on the same day.**
6. Well printed bids, properly bound and presented in **Three copies one of which is the original** must be accompanied by a bid guarantee of **One Million Rwandan francs (Frw 1,000,000)** issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids. The bids will remain valid for **120 days** starting from the deadline of bids submission.
