This payment shall be made to Account N° **25044962001/Frw** opened at I & M Bank. Bids must be delivered to the address below **before or not later than 10:00am local time** on 20/04/2026. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.
4. All bids shall be accompanied by an original bid security of One Million Sixty Thousand Rwandan Francs (**1,600,000 Frw**) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids
5. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarters Office at **10:30 am local time on the same day**.

Well printed bids, properly bound and presented in four copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned below not later than 20/04/2026 at 10:00 am.
