4. Bids must be delivered to the address below **before or not later than 10:00am local time** on 17/12/2022. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.
5. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day**.
6. Well printed bids, properly bound and presented in Three copies one of which is the original must be accompanied by a bid guarantee of One Million Rwandan francs (Frw 1,000,000) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids. The bids will remain valid for 120 days starting from the deadline of bids submission
