Well printed bids, properly bound and presented in Three copies one of which is the original must be accompanied by a bid guarantee of One Million Rwandan francs (Frw 1,000,000) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids.
