Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.

All bids shall be accompanied by an original copy of bid security Two Million Four Hundred Thousand Rwandan Francs (**Frw 2,400,000**) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids as per the format provided in the tender document.
5. Bids will be opened in a public session and in the presence of the bidders’ representatives who choose to attend in person in the conference room at RE-EUCL Headquarters at **10:30 am local time on the same day**.
