This payment shall be made to Account 2001161020000121 opened at NCBA Bank.
4. Bids must be delivered to the address below **before or not later than 10:00am local time on 30/11/2023**. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.
5. All bids shall be accompanied by a bid security of One Million Rwandan francs (Frw 1,000,000) issued by a reputable bank or any other financial institution with the validity period of One Hundred Twenty (120) days from the opening date of bids.
6. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day**.
7. Well printed bids, properly bound and presented in three copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned below not later than **30/11/2023 at 10:00 am**. Late bids will be rejected and returned unopened.
