4. Bids must be delivered to the address below **before or not later than 10:00am local time on 29./12/2023**. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.

All bids shall be accompanied by a bid security of Three Million Rwandan francs (Frw 3,000,000) or Two Thousand Four Hundred Thirty United State Dollars (USD 2430) issued by a reputable bank or any other financial institution with the validity period of One Hundred Fifty (150) days from the opening date of bids.
6. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day**.
