- 4. Bids must be delivered to the address below <u>before or not later than 10:00am local time</u> on <u>2.9./12/2023</u>. Electronic bidding <u>will not</u> be permitted. Late bids will be rejected and returned unopened.

All bids shall be accompanied by a bid security of Three Million Rwandan francs (Frw 3,000,000) or Two Thousand Four Hundred Thirty United State Dollars (USD 2430) issued by a reputable bank or any other financial institution with the validity period of One Hundred Fifty (150) days from the opening date of bids.
- 6. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at 10:30 am local time on the same day.
