All bids shall be accompanied by bid guarantee of Five Million Rwandan francs (Frw 5,000,000) or Five Thousand United State Dollars (USD 5,000) for lot I and Two Million Rwandan Francs (Frw 2,000,000) or Two Thousand United State Dollar (USD 2,000) issued by a reputable bank or other financial institutions recognized;
