Energy Utility Corporation Limited (EUCL) now invites sealed bids from eligible bidders, specialized in the field, for the “Supply of Lubricants for Hydro Power Plant and Thermal Power Plant under framework arrangement for two years (Lot 1 & Lot2).” The tender comprises of two (2) lots mentioned below and the participation to the competition is open on equal conditions to all companies specialized in the field. The said lots are as follows;

LOT 2: SUPPLY OF LUBRICANTS FOR JABANA 20MW TPP.

A complete set of Bidding Documents in English may be obtained by interested bidders from the Procurement Unit at EUCL Head Office KN82 ST3, Nyarugenge District, Kigali City, P.O Box 5634 Kigali, and Rwanda, upon presentation of a bank deposit slip of non- refundable amount of Ten Thousand Rwandan Francs (10,000 Frw). This payment shall be made to the account n° 5044962 – 01 - 96 (Frw) opened at I & M Bank, Rwanda
5. Bids must be delivered at the address below in paragraph 9, at or before 10h00 local time on the 30TH/12/2019. Electronic bidding will not be permitted. Late bids will be rejected.

6. Bids will be opened in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices in a public session at 10h30 local time on the same day 30TH/12/2019.
7. All submitted bids must be accompanied by a bid guarantee of Three Million Five Hundred Thousand Rwandan Francs (3,500,000Rwf) or Four Thousand United States Dollars (USD 4000) issued only by a recognized and reputable commercial Bank,
8. Bids well typed, appropriately bound and presented in three copies (one original and two copies) must reach the Secretariat to the Procurement Unit at EUCL Head Office, KN 2 ST 3, Nyarugenge District, P.O. Box 5634 Kigali City – Rwanda, **Room G114** on or before the date and time mentioned in the paragraph 7 and 8. The Outer envelope should clearly indicate the tender number and title.
9. The bids will remain valid for 120 days starting from the deadline of bids submission.
10. Bidding and the procurement process shall be conducted in accordance with the procurement User Manual of REG as updated to date.
