**PROCUREMENT METHOD: NATIONAL COMPETITIVE BIDDING (NCB)**

1. Energy Utility Corporation Ltd (EUCL), one of the subsidiaries of Rwanda Energy Group (REG) in charge of increasing generation, improve transmission and distribution, diversify the energy sources, to reduce costs and elaborate a conducive legal and regulatory framework;
2. Energy Utility Corporation Limited (EUCL) now invites sealed bids from eligible bidders, specialized in the field, for the “Supply of Lubricants for Hydro Power Plants and Thermal Power Plants under framework arrangement for two years (Lot 1 & Lot2).” The tender comprises of two (2) lots mentioned below and the participation is open on equal conditions to all companies specialized in the field. The said lots are as follows;

**Lot 1: Supply Of Lubricants for Hydro Power Plants and Jabana 1 TPP.**

**Lot 2: Supply of Lubricants for Jabana 20MW TPP.**

This payment shall be made to the account n° 5044962-01-96 (Frw) opened at I & M Bank, Rwanda
5. Bids must be delivered at the address below in paragraph 8, at or **before 10:00 am local time** on the **13/07/2020**. Electronic bidding will not be permitted and late bids will be rejected.
6. Bids will be opened in the presence of the bidders’ representatives who choose to attend in person in the conference room at EUCL Headquarter Offices in a public session at **10:30 am local time** on the same day **13/07/2020**.
7. All submitted bids must be accompanied by a bid guarantee of Three Million Rwandan Francs (**3,000,000 Frw**) for lot 1 and Five Million Rwandan Francs (**5,000,000 Frw**) for Lot 2 issued by a reputable commercial bank in Rwanda. **Bidders must submit the bid securities with a validity of 180 days from the date of issue for each lot separately.**

8. Bids well typed, appropriately bound and presented in three copies (one original and two copies) must reach the Secretariat to the Procurement Unit in **Room G114 on first floor** at EUCL Head Office, KN 2 ST 3, Nyarugenge District, Kigali City, on **13/07/2020** at 10:00am. The Outer envelope should clearly indicate the tender number and title.
9. The bids will remain valid for **180 days starting from the deadline of bids submission**.
10. Bidding and the procurement process shall be conducted in accordance with the procurement User Manual of REG as updated to date.
