TITLE OF TENDER: ELECTRIFICATION UNDER FRAMEWORK CONTRACT FOR SCHOOLS WITH SMART CLASSROOMS LOCATED IN OFF-GRID AREAS

1. The Energy Development Corporation Limited (EDCL) has received the fund from the Government of Rwanda for Electrification of Off-grid Area and it intends to apply part of the proceeds of this fund to payments;
2. EDCL now invites eligible bidders to submit their offer regarding the **tender for electrification under framework contract for schools with smart classroom located in off-grid areas**;
3. Interested eligible bidders may obtain further information from EDCL Head Offices at Kigali City Tower (KCT), KN2 ST, Nyarugenge District, Kigali City, in Procurement Office, 10th floor or request clarification on Email: procurement@edcl.reg.rw, erukinirwa@edcl.reg.rw. The bidding document will be obtained upon presentation of a prepaid Bank slip of non-refundable amount of **Ten thousand Rwandan francs (10,000 Rwf)**. This payment can be done on any account of Rwanda Revenue Authority opened in different commercial banks;
4. A bid shall be accompanied with a bid security of **Rwf 1,500,000** or its equivalent in foreign currency. Failure to submit the said Guarantee shall lead to the disqualification of the bid. The bid security shall be issued by a bank or a recognized local Insurance Company;
5. Bids well typed, appropriately bound and presented in three copies (one original and two copies) stating " **ELECTRIFICATION UNDER FRAMEWORK CONTRACT FOR SCHOOLS WITH SMART CLASSROOMS LOCATED IN OFF-GRID AREAS**" should be submitted in the Procurement Office of **EDCL Head** located in **Kigali City Tower (KCT), KN2 ST, 10th floor, Nyarugenge District, Kigali City**, **on or before 10:00 hours local time (8 a.m. GMT)** on day **29/04/2021**. Electronic bidding **will not** be permitted. Late bids will be rejected.
6. Bids will be opened in the presence of the bidders' representatives who choose to attend a person in the conference room at EDCL Headquarter Offices in public session on the same day at **10:30 hours local time (8.30 a.m. GMT)**.

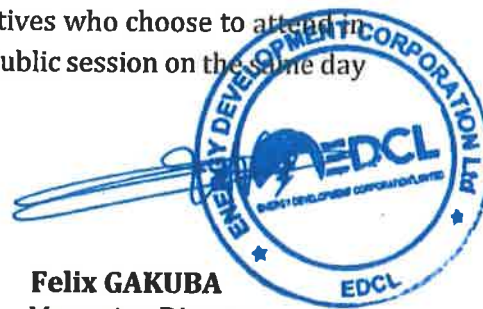
