TITLE OF TENDER: Supplying, installing, testing, commissioning and maintenance of solar water heating system in residential and non-residential sector

- The Energy Development Corporation Limited (EDCL) has received the fund from the Government of Rwanda for development of solar water heaters market in Rwanda and it intends to apply part of the proceeds of this fund to payments under the Contract for Solar Water Heaters;
- 2. A competitive and transparent procurement process is used, interested and qualified bidders are requested to submit their proposal responding to EDCL's technical requirements
- 3. Interested eligible bidders may obtain further information from EDCL Head Offices at Kigali City Tower (KCT), KN2 ST, Nyarugenge District, Kigali City, Email: <u>procurement@edcl.reg.rw</u>, <u>erukinirwa@edcl.reg.rw</u>; or in the Procurement office from 08:00 am to 5:00 pm hours local time, the bidding document will be obtained upon presentation of a prepaid Bank slip of non-refundable amount of **Ten thousand Rwandan francs** (**10,000 Rwf**). This payment can be done on any account of Rwanda Revenue Authority opened in different commercial bank;
- 4. A bid shall be accompanied with a bid security of Rwf 1,000,000 or its equivalent in foreign currency is required. Failure to submit the said Guarantee shall lead to the disqualification of the bid. The bid security shall be issued by a bank or a recognized insurance company;
- 5. Bids well typed, appropriately bound and presented in three copies (one original and two copies) stating "Supplying, Installing, Testing, Commissioning and maintenance of solar water heating system in residential and non-residential sector" should be delivered to the Procurement Office, 10<sup>th</sup> Floor at <u>EDCL Head Offices, Kigali City Tower (KCT), KN2 ST, 10<sup>th</sup> floor, Nyarugenge District, Kigali City, on or before 10:00 hours local time (8 a.m. GMT) on day 09/12/2020. Electronic bidding <u>will not</u> be permitted. Late bids will be rejected.</u>
- 6. Bids will be opened in the presence of the bidders' representatives who choose to attend in person in the conference room at EDCL Headquarter Offices in public session at **10:30 hours local time (8.30 a.m. GMT)** on the same day **09/12/2020.**
