2. Bidding will be conducted through National Competitive Bidding (NCB) in accordance with the Procurement Procedures Manual of REG/EUCL.

The Bidding Document may be obtained by interested bidders for any working days from 02/03/2026, from 9:00 am to 5:00 pm at EUCL-REG Headquarters, 1st Floor, Room N° G114, in the Secretariat Office of the Procurement Management Services of EUCL, P.O Box 5634 Kigali, procurement-eucl@eucl.reg.rw; upon presentation of proof of payment of a non – refundable amount of Ten Thousand Rwandan Francs (10,000 Frw). This payment shall be made to Account N° 25044962001/RWF opened at I & M Bank or Account N° 2001161020000121 opened at NCBA Bank, Rwanda.
4. Bids must be delivered to the address below **not later than 19/03/2026 at 10:00am local.** Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.

All bids shall be accompanied by a bid security of Six Hundred Forty Thousand Rwandan Francs (**640,000Frw**) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids. The bid security must be in the format as provided by the tender document.
6. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day.**
7. Well printed bids, properly bound and presented in Two copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned below not later than 19/03/2026 at 10:00 am. Late bids will be rejected and returned unopened.
