4. Bids must be delivered to the address below not later than ~~03./6~~./2026 at 10:00am local time. Electronic bids **will not** be permitted. Late bids will be rejected and returned unopened.
5. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarters Office at 10:30 am local time on the same date.

Well printed bids, properly bound and presented in Two copies one of which is the original must be accompanied by a bid security of One Million Four Hundred Thousand Rwandan francs (Frw **1,400,000Frw**) which is as per the format in the bidding document, issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids.
