3. The participation is open, and all conditions are equal to all interested bidders specialized in the field.
4. The Bidding will be conducted through the National Open Competitive Bidding (NCB) procedures specified in the Procurement User Manual of REG as updated to date.

9. The bids shall remain valid for 120 days starting from the deadline of bids submission. The Outer envelope should clearly indicate the tender name and title.
