- 2. The participation in this tender is open and equal conditions to all companies specialized in the field that meet the minimum qualification criteria as stated in the SBD.
- 3. This tender is made of three (3) indivisible Lots:
 - Lot1: Cleaning of Head Office/REG-EUCL, BIREMBO Substation, JABANAI Power Plant, NCC (Dispatching), JABANAII 20 MW Thermal Power Plant and branches offices in Kigali City
 - Lot2: Cleaning branches of Southern, Western and Northern provinces offices
 - Lot 3: Cleaning of Substations and Power Plants

All interested bidders are allowed to bid for all lots or any of the three lots

Site visit is not compulsory to all interested bidders, however in case any company want to do so, they must look for authorization from procurement unit before going to the site.
