All bids shall be accompanied by a bid security of Two Million Rwandan francs (Frw 2,000,000) for Lot I and One Million Rwandan Francs (Frw 1,000,000) for Lot II issued by a reputable bank or any other financial institution with the validity period of One Hundred Fifty (120) days from the opening date of bids

6. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day**.
