Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.

All bids shall be accompanied by an original bid security of Four Million Rwandan Francs (**Frw 4,000,000**) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids as per the format provided in the tender document;
