This payment shall be made to Account N° 5044962-01-96 (Frw) opened at I & M Bank, Rwanda.
7. Bids must be delivered to the address below **before or not later than 10:30am local time** on 14/09/2020. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.
8. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **11:00 am local time on the same day**.

Well printed bids, properly bound and presented in **four copies one of which is the original** must be accompanied by a bid guarantee of **Two Million Rwandan francs (Frw 2,000,000) for lot One (1) and Two Million Two Hundred Fifty Thousand Rwandan Francs (Frw 2,250,000) for lot Two (2)** issued by a reputable bank or other financial institutions. The bids will remain valid for **120 days** starting from the deadline of bids submission.
