The bids will remain valid for **120 days** starting from the deadline of bids submission. The Bid declaration of commitment to be submitted must scrupulously in conformity with the template of this tender document.
4. Well printed bids, properly bound and presented in two copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned above not later than **12/03/2025 at 10:00 am**. Late bids will be rejected and returned unopened.
