1. The Government of Rwanda (GoR) has received financing from World Bank (WB) and Agence Française de Développement (AFD) toward the cost of the Energy Access and Quality Improvement Project, and intends to apply part of the proceeds toward payments under the Contract for electrical materials.

Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on 11/02/2022 at 10:30am (local time)
6. All Bids must be accompanied by a Bid Security of Twenty-Eight Thousand US Dollars (USD 27,000). The bidder will be issued in form of a bank.
