5. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at REG Headquarter Offices at 10:30 am local time on the same day.
6. Well printed bids, properly bound and presented in two copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned below not later than 12/04/2024 at 10:00 am. Late bids will be rejected and returned unopened.
