





This payment shall be made to Account N° 25044962001/RWF opened at I & M Bank. Bids must be delivered to the address below **before or not later than 10:00am local time on 26./11./2025**. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.

All bids shall be accompanied by an original copy of bid security of Seven Million Rwandan Francs (Frw 7,000,000) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids as per the format provided in the tender document.
5. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day**.

Well printed bids, properly bound and presented in four copies one of which is the original must reach the Secretariat of the Procurement Management at the address mentioned below not later than 26./11./2025 at 10:00 am.
