

This payment shall be made to Account N° 25044962001/RWF opened at I & M Bank. Bids must be delivered to the address below **before or not later than 10:00am local time** on 19./10./2025. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.
4. All bids shall be accompanied by an original bid security of One Million Rwandan Francs (**Frw 1,000,000**) issued by a reputable bank or other financial institutions with the validity period of One Hundred Fifty (150) days from the opening date of bids
5. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time on the same day.**
