The Energy Utility Corporation Limited (EUCL) hereby invites sealed bids from eligible bidders for submitting their best offers for the tender for "Supply of Various Electrical Materials, spare parts and equipment under Framework Agreement for a Period of Two Years, with possibility of Renewal" as indicated in detail in the statement of Requirements.
2. The tender comprises of eight (8) Lots mentioned below and the participation to the competition is open on equal conditions to all companies specialized in the similar domain. Bidders are allowed to bid for all the lots, evaluation shall be done on lot-by-lot basis. The said lots are as follows:

LOT 1: SUPPLY OF CABLES & CONDUCTORS (Alu, ACSR & Steel) and ACCESSORIES (Bid security Of Two million Rwandan Francs (2,000,000Rwf) or 1,831USD).

LOT 2: SUPPLY OF LV and MV UNDERGROUND CABLES (COPPER) and ACCESSORIES (Bid security of Three million Rwandan Francs (3,000,000Rwf) or 2,747USD).

LOT3: SUPPLY OF INSULATORS AND LINE HARDWARE (Bid security of Two million Rwandan Francs 2,000,000Rwf) or 1,831USD).

LOT4: SUPPLY OF LV PROTECTION & LV CURRENT TRANSFORMERS (Bid security of one million four hundred thousand (1,400,000Rwf) or 1,282 USD).

LOT5: MV PROTECTION (HRC FUSE, FUSE LINKS, SECTIONRIZER, SURGE ARRESTORS. (Bid security of Three million Rwandan Francs (3,000,000Rwf) or 2,747USD)

LOT6: SUPPLY OF LV DISTRIBUTION BOX (EMPTY) (Bid security of One million three hundred thousand Rwandan Francs (1,300,000Rwf) or 1,190USD).

LOT7: SUPPLY OF AUTORECLOSER & COMBI UNIT (Bid security of Three million Rwandan francs (3,000,000Rwf) or 2,747 USD).
