This payment shall be made to Account 25044962001/RWF opened at I & M Bank, Rwanda and to the account No 00040-00691030-35 (USD) opened at Bank of Kigali (BK) with Code IBAN: RW 40000400069103035003.
6. Bids must be delivered to the address below **before or not later than 10:00am local time** on 13/09/2022. Electronic bidding **will not** be permitted. Late bids will be rejected and returned unopened.
7. Bids will be opened in a public session and in the presence of the bidders' representatives who choose to attend in person in the conference room at EUCL Headquarter Offices at **10:30 am local time** on the **same day**.

Well printed bids, properly bound and presented in **Three copies one of which is the original** must be accompanied by a bid guarantee of **One Million Rwandan francs (Frw 1,000,000) or One Thousand United State Dollar (USD 1,000)** issued by a reputable bank or other financial institutions. The bids will remain valid for **120 days** starting from the deadline of bids submission.
