The Government of Rwanda has received financing from the African Development Fund (ADF) hereinafter called the Bank toward the cost of Transmission System Reinforcement and Last Mile Connectivity Project (TSRLMC) and intends to apply part of the proceeds toward payments under the contract for **Supply of Prepayment Meters and Ready Boards**. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
2. The Energy Development Corporation Limited now invites sealed Bids from eligible Bidders for **Supply of Prepayment Meters and Ready Boards**. The tender is in two (2) lots as detailed below and bidders may have the option to bid for any one lot or both lots. Bidders who intend to offer discounts if they are awarded both lots will be allowed to do, as long as these discounts are explicitly stated in the Letter of Bid.
